Step 4: Click the language that you would like to hear, first click  button.

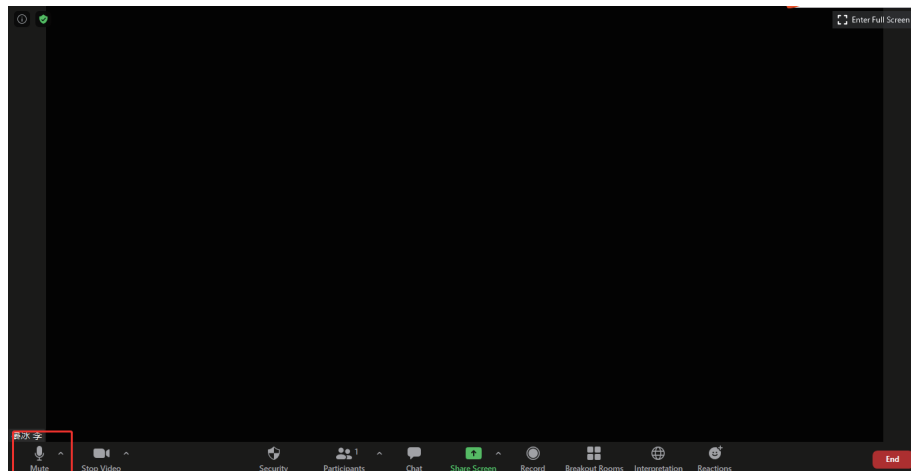


Please do not listen to the channel of the language you speak during the zoom meeting or you would interfere with the interpretation.

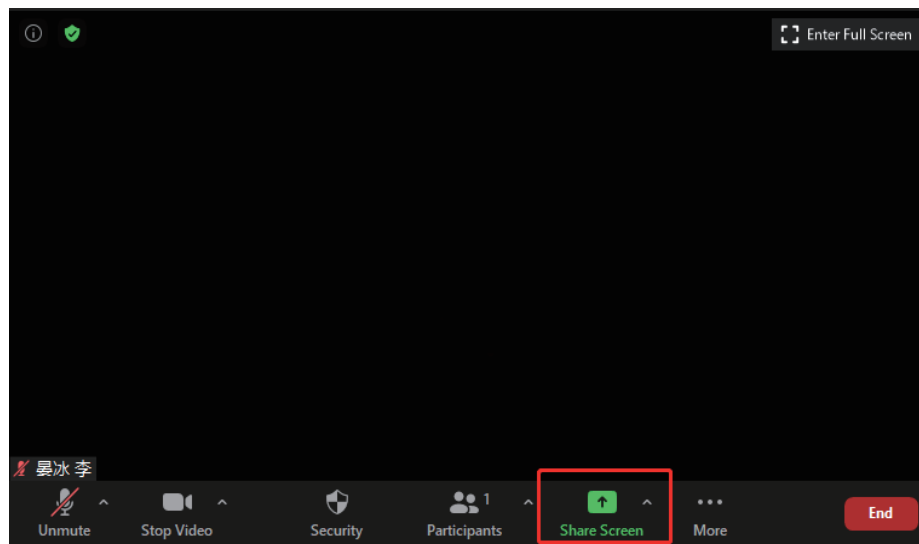

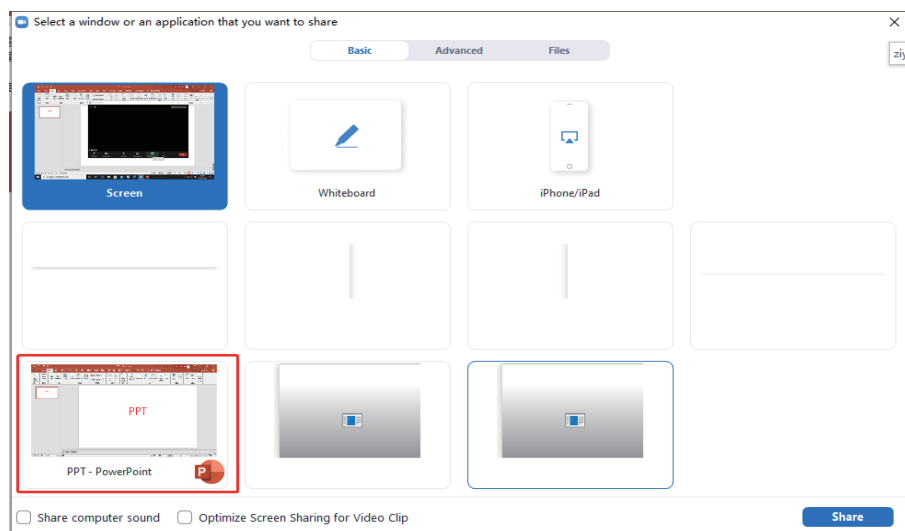

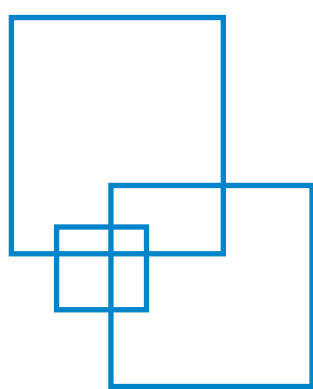
