Appendix 2: Qualification Selection and Review

International Competition for Architectural Concept Scheme of Permanent Site of Greater-Bay Science Forum Oualification Selection and Review

I Preface

- 1. For the international competition for the architectural concept scheme for the permanent site of the Greater-Bay Science Forum, the method of open solicitation and optimum selection shall be adopted to select the formal participating organizations from all the participating organizations registered as per the rules (including the consortiums, similarly hereinafter).
- 2. To ensure that the competition is "open, fair and just", the detailed rules for the qualification selection and review shall be formulated as per the relevant national laws and regulations in combination with the characteristics and requirements of this competition.
 - 3. The organizer reserves the rights to interpret and revise the rules.

II Qualification Selection and Review Expert Group

- 1. The qualification selection and review expert group shall be reviewed and established by the competition committee in accordance with the law.
- 2. The main responsibility of the qualification selection and review expert group is to carry out careful review to the registration data submitted by the participating organizations, select the best formal participating organizations and complete the review report. All the members of the qualification selection and review expert group for this project have the responsibilities and obligations to carry out confidentiality and commitment to the information submitted by all the participating organizations.

III. Qualification Selection Measures

- 1. Qualification Selection Procedures
- Step 1: Compliance Review;
- Step 2: Optimum Review;
- Step 3: Complete the Review Report.
- 2. Qualification Selection Method
- 2.1 First Stage (Compliance Review)

All the organizations participating in the international competition for the architectural concept scheme for the permanent site of the Greater-Bay Science Forum shall provide registration materials as per the relevant requirements of "registration documents for qualification Selection" in the registration announcement. The competition organization agency will review compliance of the registration materials (for the details, see Attached Table 1). If any item fails to meet the "Registration Qualification Conditions", it will be deemed to fail to meet the compliance review. The competition organization agency will submit the list of organizations meeting the compliance review to the qualification selection and evaluation expert group for review and confirmation.

During the compliance review, the competition organization agency or the qualification selection and evaluation expert group may ask for clarification of the registration documents if there are doubt or unclear matters, and the participating organization must submit clarification materials within the specified time as part of the qualification review data. Inconsistency in the opinions of the qualification selection and review expert group on the qualification of the participating organizations shall be handled in the principle of obedience of the minority to the majority.

If the number of the organizations meeting the compliance review is less than or equal to 9, they will be directly enrolled as the formal participating organizations, will not be preferentially selected. If more than 9 organizations passed the compliance review, the optimum review will be conducted, and the top 9 organizations will be selected as the formal participating organizations.

2.2 Second Stage (Optimum Review)

The registered participating organization shall submit the performance data (for the details, see Appendix 1 "Format of the Qualification Selection Registration Document" and Attached Table 2), and the qualification selection and evaluation expert group shall finally select 9 formal participating organizations.

The participating member of the consortium can only establish a joint relationship with one participating organization, and make it clear that one party is the main party of the consortium. The original copy shall be affixed with the official seal.
5.	Participation Commitment Letter	The project principal or the creative team of the participating organization shall promise to directly participate in the whole process of this competition and architectural scheme design; (1. Provide the letter of commitment from the participating organization and affix its official seal or signature; 2. Provide the personnel list).

Notes: if the participating organization fails to meet any item of the conditions in this form, it will be deemed to have failed the compliance review.
