Fair boosts city's opening-up process

Delegates from foreign countries and enterprises sign business deals and speak highly of region's commercial potential

hengdu, a megacity in western China, is accelerating the pace of its opening-up by hosting a growing number of international

The latest event is the 16th Western China International Fair, a State-level international exposition under the co-sponsorship of China's 16 ministries, 12 provinciallevel administrative units and the Xinjiang Production and Construction Corps in Northwest China.

Chengdu is the permanent site of the Western China International Fair.

This year's event, held from Nov 3 to 14, drew delegates from 91 countries and regions, including Guinea President Alpha Conde, Serb President Milorad Dodik, German Vice-Chancellor Sigmar Gabriel, and Afghanistan's second vice-president Mohammad Sarwar Danesh.

The exhibition area is as large as 200,000 square meters. Sixteen countries set up their national pavilions, more than any of the previous 15 sessions of the fair, according to the organizers.

Nearly 9,000 firms from around the world attended this year's fair, including some of the world's leading firms, such as BMW, Daimler, METRO, DHL, Google and Huawei

The fair highlighted China's Belt and Road Initiative. Four halls featuring the initiative were set up and several activities centered on the initiative as their main topic.

Sino-German cooperation strengthened by tech deals

Major progress was made in the cooperation between Chengdu and Germany dur-ing the 16th Western China International Fair held in the city earlier this month.

A Sino-German innovative industrial cooperation zone, covering a total area of 22 square kilometers, was inaugurated in Chengdu Science City, a hub of new technology, industry and business in the Tianfu New Area.

Liu Yutong, director of the investment services bureau at the Chengdu administrative committee of Tianfu New Area, said the zone will be the main platform for Sichuan to conduct innovative cooperation

with Germany. It has planned 10 industrial areas, covering fields such as scientific research, medical health, intelligent manufacturing and international trade and business.

Other Sino-German cooperation areas in Chengdu include a 7-square-kilometer industrial demonstration park in Chengdu Hi-tech Zone, a 58.5-squarekilometer auto industry park in Longquanvi district, as well as a 30-square-kilometer small and medium-sized enterprises cooperation park in Pujiang county.

Six companies signed cooperation agreements with the Chengdu administrative committee of Tianfu New Area and Chengdu Tianfu New Area Investment Group Co Ltd at the inauguration ceremony, with investment totaling 4 billion yuan (\$590 million).

The cooperation projects are mainly in high-end manufacturing, environmental protection, research and development and high-end services.

BMW China Automotive Trading Ltd will cooperate with Global Car Sharing & Rental Co Ltd to offer timeshare leasing services of electric cars to citizens in Tianfu New Area.

BMW China will provide 100 BMW i3 vehicles to the project. Customers will be able to rent the cars by simply using an app on their smart phones.

Germany-based ALBA Group, the world's leading recycling and environmental services company, will cooperate with local companies to offer services in Tianfu New Area, including water treatment, solid waste disposal and river improvement.

Axel Schweitzer, chairman of ALBA Group, said the group has together with Chengdu Techcent Environment Industry Co Ltd established the largest-scale cooperation agre ment between a German and Chinese company in the field of environmental protection.

Deng Qinhua, chairman of Chengdu Techcent Environment Industry, said the company has set up an innovation center and an engineering technology center in Chengdu Science City.

An industrial fund with a total investment of 5 billion yuan was also established to provide financial support to German companies that invest in Chengdu

Western China hub draws leading intl projects

Chengdu is drawing hightech projects from around the world as it becomes more integrated into the world economy.

As an economic center in western China, the city attracted a number of highend manufacturing projects during the 16th Western China International Fair, a State-level international exposition held in the city earlier this month.

Zhejiang Geely Holding Group signed three investment agreements worth 35.5 billion yuan (\$5.15 billion) with the city to strengthen cooperation in auto manufacturing.

Geely started its investment in Chengdu in 2007 by setting up a manufacturing base. Then in 2010, the company purchased Volvo, which is headquartered in Gothenburg, Sweden, and later built Volvo's first manufacturing plant on the Chinese mainland in Chengdu.

One of the newly signed projects will be located in the Chengdu part of the Tianfu New Area, China's 11th national-level development area approved by the State

Council in October 2014. It will produce high-performance, purely electric vehicles under the Volvo brand, as well as locally-branded purely electric vehicles.

The second project will bring in Volvo's Scalable Product Architecture, a global fullsize unibody automobile platform developed and produced by Volvo

The third project will produce Geely's BMA vehicles, using the latest modular architecture system developed jointly with Volvo, as well as advanced hybrid and plug-in hybrid power systems.

The three projects will have an annual production capacity of 600,000 units.

Li Donghui, executive vice-president of Geely, said the three projects will further boost the development of Geely's Chengdu base. He expects the annual output

bases for new energy vehicles, serving the markets along the Belt and Road. The Chengdu city government also signed a strategic cooperation agreement with a group of leading new energy carmakers to establish a

new energy vehicle industry alliance. The Chengdu New Energy Vehicle Industry Alliance aims to establish a cooperation platform for the whole industrial chain of Chengdu's new energy auto industry, helping to make the city an internationally competitive

new energy vehicle manufac-

turing base. The auto industry is a pillar of Chengdu's economy. The Longquanyi district, located in eastern Chengdu, has gathered automakers including Dongfeng Peugeot Citroen Automobile, FAW-Volkswagen and Geely, as well as many car component suppliers.

The city is expected to produce 1.1 million vehicles this year, and the local auto industry is expected to generate a total output value of 200 billion vuan.

During the fair, Germanybased Siemens AG signed an vuan with BOE Technology Group's Chengdu subsidiary Chengdu base into one of to help the latter upgrade its

production line. According to the agreement, Siemens wil form BOE's production line in Chengdu according to the standards of the German Industry 4.0 strategy.

During the Western China International Fair in 2011, Siemens signed an investment agreement with the Chengdu Hi-tech Zone to establish the company's first modern digital factory in China.

In July, Siemens announced that it would increase its presence in Chengdu by setting up an independent legal company with registered capital of 330 million yuan.

"Choosing Chengdu was a wise decision," said Roland Busch, member of the managing board of Siemens during this year's Western China International Fair.

Chengdu will also upgrade its cooperation with Dell Inc to make its Chengdu manufacturing base into one of the company's most competitive R&D and manufacturing bases in the world, according to the city's investment promotion commission.
