Message by Chairman

We had an extraordinary year in 2020. CNMC carried out response to the epidemic, and enterprise reform and development in a coordinated manner. CNMC had made steady progress in project development, improved management capabilities, realized record economic benefits, put in actions for sustainable development, and scaled new heights in terms of the quality and efficiency of enterprise development, and contributed to the security of national important resources.

First, resolutely pressed ahead with the reforms, and scaled new heights in terms of economic benefits. In 2020, when the price of non-ferrous metals remained low and then rose, copper prices rose slightly, and prices of zinc, nickel, etc. dropped throughout the year, we focused on improving financial management and implemented the three-year action plan for the reform of state-owned enterprise to improve corporate governance, upheld the list-based management and hierarchical authorization for the powers of the board of directors, realized the coordination of various governance entities, and modernized the corporate governance system and governance capabilities. CNMC promoted "staggered development": we went all out to scale up production capacity for overseas new production projects such as Somidez and Lualaba; domestic companies such as CNMC Hongtoushan quickly resumed work and production, with a view to improving economic benefits. CNMC "tightened the screws"; the progress of key construction projects such as CNMC Africa Mining's Southeast Ore Body Project and Daye's 400,000-metric ton project picked up speed, key scientific and technological projects reached the evaluation targets, and the yield rate of CNFC Orient's beryllium copper alloy sheet and strip increased by 13 percentage points compared with the annual average. CNMC promoted "technology leadership"; it established international R&D centers and overseas laboratories, set up expert technical committee, undertaken five projects under the "1025 program", and won one second prize at the National Prize for Progress in Science and Technology. The company's total profit and net profit, and the output of non-ferrous metal products hit record highs, and the assetliability ratio fell below 65% for the first time.

Second, focused on the fulfillment of responsibilities and promoted sustainable development. We attach great importance to work safety and ensure the health and safety of employees. The mortality rate per 10 billion yuan of industrial output and the rate of injury per 1,000 people hit record lows. We set great store by environmental protection, and work to build digital mines and environmentally friendly mines. Six mines were included in the list of national environmentally friendly mines, the comprehensive energy consumption per 10,000 yuan of output value was the same year-on-year, and the sulfur dioxide emissions fell by 23.5% year-on-year. CNMC contributed to the people's well-being. During the 13th Five-Year Plan period, it accumulatively donated over 82.2518 million yuan for paired-up poverty alleviation. It invested 30 million yuan in the Central Enterprise Industrial Poverty Alleviation Fund, which helped lift over 30,000 poor people in designated poverty-stricken counties out of poverty. The first secretary in residence sent by the group company was awarded the national advanced individual for poverty alleviation. CNMC donated 13 million yuan in funds and materials to Hubei Province and Huangshi City for the fight against the COVID-19 epidemic. CNMC continuously improves the quality of products and services, cements ties with partners, and strengthens supplier access, evaluation and management. The yield rate of its products reached 96.34%, and customer satisfaction rate was 96.11%.

Remain true to our original aspiration and advance our cause. 2021 is the first year of the 14th Five-Year Plan period and the first year of building a modern socialist country in all respects. Focusing on high-quality development, CNMC never wavers in its efforts to "go global", endeavors to "become stronger and produce excellent products", and "contributes to the country with resources". Driven by innovation, CNMC endeavors to become stronger and excellent in terms of resources, new materials, engineering, and trade, move faster to become a world-class mining enterprise with global competitiveness, and strive to meet the needs of the people for a better life!

Shouldering the mission of "ensuring the security of national important resources", CNMC is one of China's first non-ferrous metals company to implement the "going global" strategy and one of the most successful companies to foster international cooperation. It has operations in over 30 countries, involving more than 40 varieties of non-ferrous metals. CNMC owns 19.07 million metric tons of heavy non-ferrous metal resources at home and abroad, and is a Chinese company that develops copper resources overseas for the longest time, has the best industrial chain, and the largest number of projects. CNMC has 27 second-level companies and five domestic and overseas listed companies. CNMC ranks 18th among the "Top 50 Chinese Enterprises for Globalization", 39th among the "Top 100 Chinese Multinational Companies", and 62nd among the "China's Top 500 Manufacturing Companies". CNMC was awarded the titles such as China Band "Huapu Award", the "70 Chinese Brands on the 70th Anniversary of the Founding of the People's Republic", and the Meritorious Enterprise for Strategy of China's Non-ferrous Metals Industry for Overseas Resource Development.

Serve the national strategy

CNMC unswervingly pursue the mission of "serving the country through resources", leverage the first-mover advantage and take multiple measures to ensure the supply of important nonferrous metal mineral resources which are in short supply in China. Relying on the domestic and international markets as well as resources, we actively foster cooperation in development of nonferrous metal resources at home and abroad, and ensure better development of resources.

The company boasts 19.07 million metric tons of heavy non-ferrous metal resources, and 11.92 million metric tons of copper resources at home and abroad. Through domestic production and transport of overseas products back to China, the company contributes about 1 million metric tons of copper to the national economy every year, which account for 8.33% of the apparent consumption of copper (output + net imports, about 12 million metric tons per year). The company has obvious competitive advantages in the main non-ferrous metal varieties such as copper, nickel, lead, zinc, tungsten, and tin, and has formed a copper-based "whole industrial chain" for the development of non-ferrous metal resources. The company is committed to becoming the pillar force in ensuring the security of national important resources.





We attach great importance to work safety and environmental protection. We continuously improve the safety management system and environmental management system, step up investment in work safety and environmental protection, raise the awareness and ability of all employees in work safety and environmental protection, and ensue zero major safety accidents and environmental pollution events.

Have an international perspective and become the "first" in many respects

We shoulder the mission of "ensuring the security of national important resources". We are one of the earliest and most successful companies in China's non-ferrous metal industry to "go global" and conduct international investment and cooperation, and has served as a bridge of friendly exchanges between China and foreign countries. Many projects are covered by intergovernmental framework cooperation and become a model of friendly cooperation between China and foreign countries. We have undertaken projects worth over 130 billion yuan in more than 30 countries along the Belt and Road, involving more than 40 varieties of non-ferrous metals. It ranks second among central enterprises in terms of transnational index.

CNMC is one of the largest importers of blister copper in China, and the first enterprise to ship copper products overseas back to China. The blister copper shipped back to China every year accounts for nearly a quarter of China's total imports. CNMC one of the world's top three companies in the tantalum industry and has China's only beryllium material research and production base. CNMC has invested in and developed 9 copper mines, 9 copper smelting plants, one gold mine, one nickel mine, and one zinc mine, including China's first overseas copper mine, the first copper hydrometallurgical process smelter, the first copper pyrogenic processing smelter, the first overseas cooperation zone, the first Sino-Mongolian joint venture zinc mine, and the first Sino-Myanmar joint venture nickel mine.



In 2009, the Chambishi Copper Smelter in Zambia was put into production, with an annual blister copper output of 250,000 metric tons. It is one of China's first overseas construction projects that won "Luban Prize". It has ISASMELT furnace that is the first furnace selfdesigned and constructed by China and that has the longest furnace life in the world, and is the first in the world to use "cobalt matte-magnetic separation" technique for industrial comprehensive recovery of metallic cobalt. It is the first large-scale pyrometallurgical plant invested by a Chinese company overseas.



In 2007, CNMC invested and built the Zambia-China Economic & Trade Cooperation Zone (ZCCZ). This is the first overseas economic and trade cooperation zone established by China in Africa and the first multi-functional economic zone announced by the Zambian government.



In 2012, the Tagaung Taung Nickel Mine in Myanmar invested and built by CNMC was the first cooperation project in mining between the Chinese and Myanmar governments and the largest mining investment project in ASEAN countries during the "Eleventh Five-Year Plan" period by the Chinese government.



In 2005, the Tumurtin-Ovoo Zinc Mine invested and developed by CNMC in Mongolia was put into operation. It is the first Sino-Mongolian joint venture zinc mine, and was rated a "Model of Sino-Mongolian Cooperation" by the governments of China and Mongolia, becoming a model for Chinese companies "going global".

Keep to responsibilities and work to improve people's well-being

We make earnest efforts to work for the public good and fulfill our social responsibilities. In China, during the "Thirteenth Five-Year Plan" period, we donated money and materials worth 82,251,800 yuan for targeted impoverished areas; invested 30 million yuan in the Central Enterprise Industrial Poverty Alleviation Fund; helped Lianghe County raise more than 11 million yuan in poverty alleviation funds, which helped over 30,000 poor people get rid of poverty, and contributed to securing a decisive victory in building a moderately prosperous society in all respects. We paid taxes in excess of USD 800 million abroad and donated more than USD 50 million. The China-Zambia Friendship Hospital we invested in is the most advanced international hospital in Zambia. We organized the Bright Eye Event in Zambia, under which 109 impoverished cataract patients underwent the eyesight rehabilitation operations.

Through benchmarking and analysis, scientific research was conducted on three generic technology research projects: "research on the comminution and separation of complex low-cobalt, high-magnesium copper ore from multiple sources and its regulation control", "research on key technologies for efficient use of raffinate from complex low-cobalt, high-magnesium copper ore", and "research on the ways to reduce water expansion in copper and cobalt hydrometallurgy".

The ZCCZ conducted benchmarking analysis of first-class multi-functional economic parks, and improved management capabilities in terms of strategic leadership, execution, organizational management, financial management, and risk management.

To implement the strategy of innovation-driven development, the company continuously increase investments in innovative research and development, focuses on making breakthrough sin major key technical issues that restrict the corporate development, fosters cooperation between industry, universities and research institutes, and strengthens the new strengths in the company's innovative development.

In 2020, the company evaluated 9 pieces of technological achievements, applied for 15 scientific and technological awards in the non-ferrous metal industry, won 3 first prizes, 2 second prizes, and 3 third prizes as the initiating company, and selected 125 corporate science and technology awards. The achievements of "Key technology and application of coordinated large-scale disposal of waste circuit boards in copper concentrate oxygen-enriched top-blown smelting" made by CNMC Daye were world-class results and won the first prize for scientific and technological progress in nonferrous metal industry.

In 2018, NFC Pump Industry established an innovation studio for diaphragm pumps. Since its inception 3 years ago, the innovation studio has organized a slew of activities to remove technical bottlenecks and difficulties in production and operation, with a focus on work safety, technological progress, cost reduction and efficiency improvement, energy conservation and environmental protection. Outstanding innovation results have been achieved. By the end of 2020, the innovation studio had held more than 40 seminars, organized 15 campaigns for technical breakthroughs, 9 technical seminars, and 16 training sessions. It applied for one utility model patent. Major progress has been made in the current stage in the "Technological Innovation in Assembly of Hydraulic Two-position Two-Way Valve for Diaphragm Pumps" and "Nitrogen Recycling of Nitrogen Package for Diaphragm Pumps". At the innovation studio, highly skilled talents, technical leaders and model workers play a demonstration and leading role in the company-wide efforts to "pursue craftsmanship, acquire skills, show dedication and demonstrate innovation ability".

In 2020, CNMC's Luanshya Muliashi hydrometallurgy plant carried out innovations in the use of sulfuric acid raw materials in copper production. Thanks to innovative practices such as reducing the total amount of acid used in dump leaching, the modification of the sulfuric acid addition system, and cutting the unit acid consumption of easily leaching ores, the plant has cut the cost of sulfuric acid by USD 1,384,900, a year-on-year decrease of 11.20%.

It ensures China's self-sufficiency in high-performance rolled copper foil base materials, improves technological progress in the field of highend copper processing and the competitive edge of the enterprise, and has resolved the "bottleneck" problem of rolled copper foil base materials used in the 5G communications field.

China Nonferrous Metals (Guilin) Geology and Mining Company independently developed ion substitution and removal technology to reduce cadmium pollution in the soil

China Nonferrous Metals (Guilin) Geology and Mining undertook the investigation and restoration of heavy metal pollution in farmland soil in Moditang Village, Gongcheng County, Guilin City, a key project set by the central environmental protection inspection team and a key project of the pilot farmland soil pollution control and restoration project under the Ministry of Ecology and Environment. It used proprietary ion substitution and removal technology to restore farmland. The effective state of cadmium in the soil is cut by more than 90%, and 100% of crops during random inspection meets the standards.

Move faster to build digital mines

In keeping with the trend of digital transformation, the company pressed ahead with the construction of digital, IT-based, virtualized, intelligent, and integrated mining, promotes process reengineering, optimizes allocation of resources, and ensures modernized management system and capabilities. In 2020, the company established the Industrial Intelligence Division, and signed the agreement on digital mine construction with four mines on a pilot basis in 2021.



CNMC Hongtoushan beneficiation plant completed the phase-II copper flotation process and swirler transformation, which greatly improved the recovery rate of useful elements, reduced staff and consumption, with obvious economic benefits.

CNMC Africa Mining carried out digital transformation of the west ore body to improve the grade of crude ore

Through optimized design, purchase of equipment, training and on-site simulation experiments, CNMC Africa Mining carried out the digital transformation of the west ore body by leveraging the results of research on high-efficiency trackless mining technology in the IT-based largescale panel. In 2020, the production capacity of the west ore body increased significantly. The extracted ore tonnage reached 1.39 million metric tons, exceeding the designed capacity by 39%. The ore grade was 2.02%, and the rate of dilution and loss rate of the stope was 7.6% and 21.7%, respectively, a year-on-year decrease of 1.1% and 1.6%. A number of indicators performed best in recent years, with significant economic benefits.

NFC strengthens source management to protect employees' occupational health

China Non-ferrous Metal Industry's Foreign Engineering and Construction Co., Ltd. (NFC) keeps to the policy of "prevention first, combination of prevention and treatment" for occupational diseases. In accordance with the laws and regulations, the company carries out the treatment and control of dust, radioactive materials and other toxic and harmful factors, and conducts pre-evaluation of occupational hazards and the evaluation of occupational hazard control. The company regularly inspects and evaluates occupational hazards in the workplace to provide employees with a work environment in line with national occupational health standards and requirements, and offer necessary occupational health protection facilities and supplies to reduce the possibility of exposure to occupational hazards. In 2020, NFC invested a total of 37.1342 million yuan in work safety.

- The subsidiaries of NFC carry out safety prevention and control work of various types according to their own situation:
- In 2019, all relevant branches and departments of CNMC Zinc adopted corresponding control measures for the points of operation that violated the inspection standards to ensure that each monitoring point meets the requirements for each indicator and create a good and pollution-free work environment;

NFC Pump conducted inspections on occupational hazards on key sites (including rubber workshops, painting workshops, and packaging workshops), and the inspection results showed zero violations;

- International Business Department establishes on-site medical centers for key construction projects, which are equipped with professional medical staff and ambulances, as well as all kinds of medicines and materials for first aid and daily needs. Medical centers provide medical services for all employees;
- The Congo (DRC) RTR project department sprays water for dust settlement on the roads at the construction site every day.

Raise employee awareness of safety

The company carries out publicity and education on work safety, safety drills and training on work safety to raise the employees' safety awareness and ability, and ensure the company's steady development.

Optimize management methods and reduce energy use

According to industry standards and optimized management methods, CNMC Orient evaluates the energy consumption indicators of each subsidiary company based on the standard of 5% reduction every 5 years, and improves the energy system. Subsidiaries and branches carried out consumption reduction campaign and achieved impressive results: CNMC New Materials greatly increased the output of electronic pastes by cutting the output of copper products. Jinhui Energy replaced high-energy-consumption and low-efficiency boilers with energy-saving and high-efficiency boilers. In 2020, CNMC Orient had energy consumption of 27,253.8 metric tons of standard coal, a year-on-year decrease of 3.2%; the comprehensive energy consumption per 10,000 yuan output value was 0.1155 metric tons of standard coal, a year-on-year decrease of 11.36%; the utilization rate of recycled water was over 90%, higher than the company's energy-saving targets during the 13th Five-Year Plan period.

Equip anode plates with new insulators to promote energy saving and consumption reduction

At the end of 2019, Chambishi Hydrometallurgy Co., Ltd. in Zambia installed new insulators on all old anode plates, which greatly improved the quality of work at the electrodeposition workshops. The current efficiency of electrodeposition was increased from about 82% to about 90%, and the energy consumption of cathode copper was greatly slashed.

Chifeng Dajingzi Mining has consistently carried out vegetation and ecological restoration and the restoration of geological environment in silver and copper mines, and achieved encouraging results.

- Cultivate plants with strong drought resistance and a significant effect of wind prevention and sand fixation on the slopes on both sides of roads and open areas in the mining area through the methods such as digging fish scale pits, cave-like land preparation, and soil-covered nets. More than 10,000 trees were planted in three years, with a greening area of over 9,000 square meters;
- Build dams to retain water and sand at the mouth of naturally flowing water gullies under the excavated slopes to avoid soil erosion caused by construction;
- Sow grass seeds on the disturbed soil to restore vegetation around the reservoir area; cover the dry beach in the reservoir area with soil; install sprinkler devices;
- Carry out publicity to raise employee awareness of green mine construction and guide them to take positive action.

Case CNMC Nickel reduces environmental disturbances at Tagaung Taung Nickel Mine to protect the local ecological environment

During the infrastructure construction period of the Tagaung Taung Nickel Mine, CNMC Nickel invested over USD 3 million beyond the project budget to protect the local 5 million sq. m virgin forest by erecting high-tower power transmission lines 20-40 meters higher than ordinary transmission lines. In the process of mining, CNMC Nickel, in view of the characteristics of red soil on Tagaung Taung such as barrenness and poor water storage capacity, adopted the method of "mining while reclaiming the land". Plant varieties with strong ability to resist drought, barrenness and heat such as acacia trees, acacia mangium, hardy sugar cane, and calico-plant are cultivated under the three-dimensional planting mode. Long-term reclamation and greening work is carried out in dumping sites, ore storage yards and stope reclamation areas. Rows of trees are planted around mining and transport roads, living quarters, and industrial sites. It is prohibited to disturb unplanned mining areas.

Adopt state-of-the-art technology to achieve ultra-low exhaust emissions

At the end of 2020, CNMC Daye Smelter used advanced technologies such as low-temperature electric demisting and ozone removal of oxynitride to achieve ultra-low emissions of smelter tail gas. Of these, sulfur dioxide emissions alone was reduced by more than 50%, equivalent to sulfur dioxide emissions of 600 metric tons per year.

Ensure ecological protection

Under the principles of "strict access, classification and grading, dynamic evaluation, and competitive elimination", it establishes a mechanism for supplier sourcing, access, selection, evaluation, rewards and punishments, and exit.

Conduct sustained inspections on selected suppliers; conduct phased evaluation on suppliers in terms of contract, acceptance, payment, aftersales service, etc.; supervise, record, analyze, and make suggestions for supplier's' performance. Register the results of supplier evaluation for the record, and make updates in a timely manner based on changes in material information on suppliers. Evaluate suppliers annually, fill out the "Evaluation Form of Qualified Suppliers", give overall consideration to supplier's performance in terms of quality, service, environment and society, including sustainable development management, environmental protection, employment of children or forced labor, etc. Caution or disqualify suppliers that fail to pass evaluation according to the performance level.

Procurement bidding e-commerce platform improves procurement quality and efficiency

In 2020, CNMC launched the procurement bidding e-commerce platform, which facilitate more suppliers to participate in the company's procurement and bidding business. The procurement business is more transparent and fairer. The system offers an automatic reminder function. Following the procurement notice, before the bid opening, and after the completion of procurement plan, reminders will be sent to persons concerned via SMS, e-mails, etc. to improve procurement efficiency. Through the bid opening hall, expert judges and the bidders can carry out sufficient technical exchanges and business negotiations. By the end of 2020, a total of 60 enterprises at all levels had used the platform to release 1,064 bidding projects and 18,374 non-bidding projects, with a total transaction value of 5.995 billion yuan. It involved 7,886 registered and chosen suppliers, and 915 registered and chosen bid evaluation experts.

To help impoverished people sell slow-selling agricultural and animal husbandry products and promote production and marketing, CNMC launched CNMC Poverty Alleviation Hall on Shanrong Business e-commerce platform in July 2020. The products available include highguality agricultural and sideline products from impoverished areas such as camellia oil, red glutinous rice, and husked rice. Consumption experience vouchers worth 500,000 yuan were issued to employees. All parties were mobilized to participate in the "October 17" National Poverty Alleviation Day activities, so that consumption-based poverty alleviation campaign plays an important role in promoting stable poverty alleviation and sustainable development in impoverished areas.

Achieve remarkable results

In 2020, CNMC invested 7.2 million yuan in support funds, and introduced 2.0248 million yuan in support funds in Lianghe County, trained 504 officials at the primary level and 156 technical personnel, purchased agricultural products worth 967,200 yuan in poverty-stricken areas, and helped sell agricultural products worth 831,900 yuan in poverty-stricken areas. When the epidemic raged, the company organized overseas affiliated companies to purchase 30,000 medical masks in Zambia for donation to Lianghe County People's Hospital, and organized training for 156 rural medical staff.
