'Extracurricular teachers' guide 'lost' teens, raising their legal awareness

n the heart of the Yimeng Mountains in Yiyuan county, Shandong province, a group of dedicated prosecutors from the Yiyuan county people's procuratorate are affectionately known as "extracurricular teachers" by the local community.

These prosecutors tirelessly traverse the mountainous terrain, offering guidance, care and legal education to vulnerable young people.

In 2022, the procuratorate established a studio with a specialized team, which consisted of experienced and dedicated legal professionals with a deep understanding of juvenile justice.

It aims to provide comprehensive judicial protection for minors.

To effectively rehabilitate and educate those who were once youth offenders, the prosecutors have implemented a personalized mentoring pro-

gram.

They partner with psychological counselors to visit the homes of these young people, providing patient counseling, comprehensive legal education, and engaging in in-depth communication.

Employing a nurturing and supportive approach, the prosecutors guide these "lost" teenagers toward a brighter path.

They also lead them on excursions to local streets, communities and public welfare activities, aiming to fill their hearts with positivity.

In the past three years, the team has successfully mentored 52 young people who were juvenile offenders, helping 23 of them gain admission to universities and 14 secure employment.

Beyond individual mentoring, the prosecutors are committed to fostering a culture of law-abiding citizens.

They regularly serve as "legal vice-principals" at numerous schools, voluntarily delivering legal education to children.

These "extracurricular teachers" actively participate in "law in schools, law in villages, and law in communities" initiatives, bringing legal knowledge directly to the young people.

Further, the prosecutors conduct a variety of engaging legal education activities, allowing children to learn about the law in an entertaining and interactive way.

Over the past three years, the prosecutors have held hundreds of legal awareness sessions, reaching over 20,000 children.

Zhang Tiantian, a prosecutor who has dedicated years to protecting minors, shared her commitment: "Teachers impart cultural knowledge and nurture talent. As 'extracurricular teachers', we aspire to use our efforts to ensure that more children can flourish under the protection of the law. This is our greatest wish."
